Subject: Two Procedural Questions on Puente

Hi Paul –

I will be handling the upcoming hearing on the CAISO testimony for Sierra Club, EDC, and Env'tl Coalition of Ventura. I had two questions I am hoping you can assist me with.

- 1) Damon Franz, one of the expert witnesses we sponsored, will be unable to testify. His colleague at Tesla, Andy Schwartz, can appear in his stead. They have very similar backgrounds, both at the PUC, then at Solar City, then at Tesla. Andy is able to appear and speak to Damon's testimony. My thought on how to handle was to docket Andy's resume and then list him as a witness on our PHC statement, and indicate in the PHC that he is prepared to testify and adopt as his own Damon's testimony. I would then ask him whether he has reviewed and prepared to speak to that testimony orally when he is introduced. Is that the correct course of action? If an objection was sustained am I correct in assuming I could just call him to testify orally without explicitly adopting Damon's testimony.
- 2) I may wish to refer to CEC documents in other proceedings in crossing CAISO. They already have a TN number. Would I just list them as exhibits with that TN number, or refile and get a new TN number for this proceeding. As far as flow during the hearing, am not sure if you can easily call up any TN number anywhere or it needs to be in this docket.

Thanks for any assistance you can provide.
