The City of Oxnard files the following prehearing conference statement in response to the Commission's August 25, 2017 Order.

1. Subject areas that require adjudication and precise nature of the dispute based on the results of the California Independent System Operator's August 16, 2017 Report and Testimony Submitted In Response to that Report.

Alternatives: Whether the LCR need can be met through preferred resource alternatives or a combination of preferred resources and a smaller peaker.

Project Benefits, Objectives, and Need: Whether the Puente project is necessary or whether will provide any of the benefits set forth in the Applicant's and Staff's testimony.

Overrides: Whether the Commission can make the findings required by Public Resources Code section 25525.
