For the September 14, 2017 Evidentiary Hearing on the California Independent System Operator's Moorpark Sub-area Local Capacity Alternative Study, the Committee believes that the perspective of Southern California Edison (SCE) would be valuable. The relative costs, timing, and feasibility of alternative technologies will be topics discussed during the hearing. As described in the Study, the California ISO collaborated with SCE in developing the base set of energy resources.
