**PURPOSE OF THE HEARING**

The Committee will conduct the hearing to allow the parties to submit evidence and argument on the Applicants' Petitions for Continued Suspension of the AFC and on Staff's Motions to Terminate Proceedings.

## **BACKGROUND**

### **San Gabriel Generating Station**

On April 13, 2007, San Gabriel Generation, LLC, currently a subsidiary of NRG Energy, Inc., filed an AFC for the San Gabriel Generating Station (SGGS). The AFC was deemed data adequate on May 23, 2007. SGGS, as proposed, would be a 696 Megawatt (MW) natural-gas-fired combined-cycle power plant consisting of two combustion turbine generators (CTG), two supplementally fired heat-recovery steam generators (HRSG), one steam turbine generator (STG), and ancillary equipment sited within the existing 60-acre Etiwanda Generating Station property located on Etiwanda Avenue in Rancho Cucamonga, San Bernardino County, California.

On June 5, 2009, a Petition to Suspend Proceedings was granted for SGGS and it has remained in suspended status since that date. On June 30, 2015, Energy Commission staff (Staff) filed a Motion to Terminate Proceeding (TN 205194) for the SGGS. The Motion seeks an Order terminating the AFC for the SGGS project for failure to pursue the application with due diligence under California Code of Regulations, title 20, section 1720.2. The Applicant for SGGS filed a Request for Additional Suspension (TN 205201) on June 30, 2015, and a Response to Staff's Motion to Terminate Proceedings (TN 205357) on July 15, 2015.

### **Sun Valley Energy Project**

On December 1, 2005, Valle del Sol Energy, LLC, currently a wholly-owned subsidiary of NRG Energy, Inc., submitted an AFC to construct and operate a simple-cycle (peaking) power plant named the Sun Valley Energy Project (SVEP), near Romoland in unincorporated western Riverside County, California. The SVEP would be a nominal 500 MW simple-cycle power plant consisting of five General Electric LMS100 natural-gas-fired turbine generators and associated equipment. The AFC was deemed data adequate on February 1, 2006.

On May 31, 2011, the SVEP Applicant's Petition to Suspend Proceedings was granted and the SVEP has remained in suspended status since that date. On June 30, 2015, Staff filed a Motion to Terminate Proceeding (TN 205195) for the SVEP. The Motion seeks an order terminating the AFC for the SVEP for failure to pursue the application with due diligence under California Code of Regulations, title 20, section 1720.2. The SVEP Applicant filed a Request for Additional Suspension (TN 205199) on June 30, 2015, and a Response to Staff's Motion to Terminate Proceedings (TN 205358) on July 15, 2015.

### **Willow Pass Generating Station**

The Energy Commission received the initial AFC for the Willow Pass Generating Station (WPGS) on June 30, 2008, which was deemed data adequate on October 8, 2008. WPGS, currently owned by NRG Energy, Inc., would consist of two power blocks, each containing one Siemens Flex Plant 10 combined-cycle unit located in the City of Pittsburg in Contra Costa County, California. The combined generating capacity of the two power blocks would be approximately 550 MW net.

On May 23, 2014, the WPGS Applicant filed a Petition to Suspend Proceedings and the WPGS has remained in suspended status since June 10, 2014. On June 30, 2015, Staff filed a Motion to Terminate Proceeding (TN 205193) for the WPGS. The Motion seeks an Order terminating the AFC for the WPGS for failure to pursue the application with due diligence under California Code of Regulations, title 20, section 1720.2. The WPGS Applicant filed a Request for Additional Suspension (TN 205200) on June 30, 2015, and a Response to Staff's Motion to Terminate Proceedings (TN 205356) on July 15, 2015.

On August 12, 2015, the Energy Commission appointed a single committee to conduct proceedings on all three of the above listed projects. The Committee will consolidate these three matters into a single hearing to further the interest of economy and efficiency of the hearings because of the overlap between the parties to the proceedings and the similarity of issues. (Cal. Code Regs., tit. 20, § 1719(a).)

### **Closed Sessions**

The Committee may temporarily adjourn into closed session to deliberate pursuant to Government Code section 11126.
