Introduction

Attached are Mission Rock Energy Center, LLC's (Applicant's) supplemental responses to the remaining California Energy Commission (CEC) Staff data requests (DRs) Sets 1 and 1A for the Mission Rock Energy Center (MREC) (15-AFC-2). The CEC Staff served the Set 1 data requests on June 24, 2016 (DRs 1-107) and the Set 1A data requests on July 15, 2016 (DRs 108-114), as part of the discovery process for the MREC project. The Applicant filed responses to DR Sets 1 and 1A on October 3, 2016. This submittal supplements the October 3rd filing by providing additional responses for DRs 15, 65, 74, 75, 83, 84, 91, 92, 97, and 109.

The responses are grouped by individual discipline or topic area. Within each discipline area, the responses are presented in the same order as presented by CEC Staff, and are keyed to the Data Request numbers (1 through 114). New or revised graphics or tables are numbered in reference to the Data Request number. For example, the first table used in response to Data Request 15 would be numbered Table DR15-1. The first figure used in response to Data Request 28 would be Figure DR28-1, and so on.

Additional tables, figures, or documents submitted in response to a data request (supporting data, stand-alone documents such as plans, folding graphics, etc.) are found at the end of a discipline-specific section and are not sequentially page-numbered consistently with the remainder of the document, though they may have their own internal page numbering system.

5.1 Air Quality (15)

Cumulative sources

15. *Please provide a list of all sources to be considered in the cumulative air quality impact analysis for staff review and approval.*

Response: A list of permitted sources in the vicinity of MREC was received from Ventura County Air Pollution Control District (VCAPCD) on December 2, 2016 and is provided in Attachment DR15-1. VCAPCD provided two (2) sets of data that contained:

- A list of all sources within the VCAPCD jurisdiction which also contains the date and type of the most recent permit action (Attachment DR15-1A)
- A subset of sources within 8 miles of the MREC site with total facility emissions in tons per year (Attachment DR15-1B)

Both data sets were combined into one with duplicate sources removed. The resultant file was then sorted by distance and any sources that were in excess of eight (8) miles from the MREC project site were deleted. Sources that were only VOCs were removed. The resultant file was then resorted by application date and any application dates prior to 2013 were deleted (Attachment DR15-1C). All three lists are provided to CEC Staff under separate cover in electronic format as Excel workbook tables.

It is important to remember that the emissions values in the above noted final source file do not represent emissions increases associated with the application action date, but rather the total source or facility emissions. A large majority of the actions taken, as noted by the action dates, were permit renewals, Title 5 renewals, modifications with no emissions increases, etc. The final file should be reviewed to determine which actions at which facilities involved permitting actions resulting in emissions increases that may not be reflected in the ambient background air quality values.

Based on the merged inventory, Applicant proposes that Staff remove the following sources from the cumulative inventory when completing Staff's model for cumulative impacts:

- Sources associated with Permit to Operate with no authority to construct (P to O No AC) which are essentially operating permit renewals
- Emergency generators and engines

Applicant also proposes to work with CEC Staff to further identify which sources to model for the cumulative analysis. The VCAPCD provided no source parameter data, other than source location, and accordingly, Applicant proposes modeling the appropriate:

- Stack height = 10 meters
- Stack diameter = 0.1 meters
- Stack exit velocity = 1 m/s
- Stack temperature = ambient + 20 degrees C

5.10 Socioeconomics (65)

Schedule, Duration, Workforce, Fiscal Benefits Update

65. *If some or all the linear components listed above were not included, please update the construction schedule and duration (noting any overlap in the schedule), workforce needed by trade and month for the linear components not included in the Socioeconomics section of the AFC, and if available, update the fiscal benefits.*

Response: Table DR65-1 shows the revised construction schedule and workforce estimates for both the plant and the linears. Total construction personnel requirements will be approximately 2,144 person-months. Construction personnel requirements will peak at approximately 149 workers in month 5 of the construction period. Average workforce over the 23-month construction period is 93 workers. The schedule for the linear components spans the first five months of the schedule previously shown for the plant (AFC Table 5.10-8).

The fiscal impacts estimated for the AFC were based on the purchase of goods and services. These estimates have not changed. The construction payroll, based on the hourly wage rate of \$83, is now \$30.85 million instead of the \$23.76 million reported in the AFC. All estimates are in 2015 dollars.

Assuming conservatively that 80 percent of the construction workforce will reside in Ventura County, it is expected that approximately \$24.68 million will stay in the local area during the 23-month construction and commissioning period. These additional funds will cause a temporary beneficial impact by creating the potential for other employment opportunities for local workers in other service areas, such as transportation and retail. No significant adverse impacts are expected to result related to the local economy and employment.

Using the IMPLAN I/O model, the revised estimated indirect and induced employment resulting from project construction within Ventura County will be 35 and 97 jobs, respectively. These additional jobs result from the estimated \$9.34¹ million in annual local construction expenditures and the estimated \$9.01 million in spending by local construction workers. The estimated \$9.01 million represents the disposable portion of the annual construction payroll (here assumed to be 70 percent of estimated \$12.87² million). Assuming an average direct construction employment of 93, the employment multiplier associated with the construction phase of the project is approximately 2.4 (i.e., $(93 + 35 + 97)/93$). This project construction phase employment multiplier is based on a Type SAM model.

Indirect and induced income impacts were estimated at \$1,824,110 and \$4,680,500, respectively. Assuming a total annual local construction expenditure (payroll, materials, and supplies) estimated at \$18.35 million (\$9.01 million in payroll + \$9.34 million in materials and supplies), the project construction phase income multiplier based on a Type SAM model is approximately 1.4 (i.e., $[\$18,351,240 + \$1,824,110 + \$4,680,500]/\$18,351,240$).

5.11 Soils and 5.15 Water Resources (74, 75, 83, 84)

Floodwaters

74. *Discuss the expected heights, velocity, duration, rate of rise, and sediment transport of the floodwaters. Demonstrate that final construction would not exacerbate flooding of adjacent properties.*

Response: The Applicant objected to this data request on August 1, 2016. Staff and the Applicant further discussed this data request at the August 26, 2016 data request workshop. The Applicant understands that Staff would like to better understand whether the elevation of the site will alter floodwater flows, and if adjacent properties would be affected by Applicant's plan to import fill to the MREC site to raise it above the 100-year floodplain. Once finalized, a Conditional Letter of Map Revision Based on Fill (CLOMR-F) will be submitted to the Federal Emergency Management Agency (FEMA) with concurrent submittal to Staff.

The technical report documents to be submitted to FEMA indicated that the planned fill will not increase the Base Flood Elevation for any property located within the regulatory floodway, as required by the Ventura County Floodplain Management Ordinance. (Note: while the project is located in the floodplain, it is not located within the floodway.) The technical report documents to be submitted to FEMA do indicate that models show that the proposed fill is expected to create minor increases in the 1 percent Annual Chance floodplain elevation, with a maximum increase of 0.48 feet approximately 300 feet upstream of the project. Model results indicate that the proposed project will be compliant with both the Ventura County Floodplain Management Ordinance and Section 60.3 of the FEMA National Flood Insurance Program (NFIP) regulations.

Cumulative Effect

75. *Demonstrate that the cumulative effect of Mission Rock when combined with other property uses (that must also comply with floodplain LORS when the updated FEMA maps become effective) do not increase the water surface elevation of the base flood more than one foot at any point.*

Response: Please see the response to Data Request 74 above. The technical report will address this issue.

Industrial Waste Water

83. *Please explain the ability of Patriot Waste Water's to accept Mission Rock industrial wastewater at the treatment facility (815 Mission Rock Rd).*

Response: Patriot Environmental Services is currently pursuing the required sewer discharge permit with the City of Oxnard and a Conditional Use Permit modification from Ventura County. The Applicant understands that Patriot Environmental Services has met with City and County staff and various elected officials to discuss the project and address concerns related to safety and compliance stemming from previous operations of this facility. Patriot expects their Mission Rock facility to be fully operational in 2017, well in advance of MREC's commencement of operations.

Alternative Wastewater Plans

84. *Please discuss any other alternative plans for wastewater disposal, and describe the schedule and approvals that would be required to utilize the alternative disposal methods.*

Response: The Applicant is not currently pursuing alternate wastewater disposal plans.

5.12 Traffic and Transportation (91, 92, 97)

Imported Fill Delivery Route

91. *Please provide the full imported fill soil delivery route from source to site, including respective roadway segment/ intersection LOS analysis for any roadway segment or intersection not previously addressed in the AFC*

Response: During months 2 through 6 (five months total) of construction, trucks will be importing fill from the borrow site in Fillmore, located on State Route (SR) 23 (Grimes Canyon Road), approximately 18 miles northeast of the site. To access the quarry, trucks will travel on SR 126 and 23, which are both designated truck routes within the City of Fillmore. Trucks will leave quarry and travel northeast on SR 23 (Grimes Canyon Road), turn left (westbound) onto SR 126 and exit SR 126 at Briggs Road. Trucks will turn left onto Briggs Road (southbound); turn right onto Pinkerton Road (westbound), turn left (southbound) onto Mission Rock Road and then right (westbound) onto Shell Road. Trucks will use the project driveway on Shell Road. The truck route is illustrated in Attachment DR91-1, Import Fill Delivery Route. This route description and figure were provided in a previous response for DR 91, but are included again for convenience.

During months 2 through 6, it is estimated that there will be an average of 61 soil import trips per day travelling between the quarry and the project site. Of these, 61 delivery/haul truck trips, it is assumed that 6 truck trips will arrive and depart during each peak hour. The remaining truck trips will be spread throughout the day. At a ratio of 1.5 passenger cars for each truck, this is equivalent to 92 daily passenger car equivalents (PCEs) and 9 peak hour PCEs.

While the soil import process is expected to occur at a consistent rate over the 5-month soil import duration (61 loads per day, 22 days per month), it is possible there may be some variation in the daily trips. The maximum daily peak for soil import truck trips is not expected to exceed 100 loads per day.

Roadway Segment Analysis

Average daily traffic counts were obtained from Caltrans for SR 23 and SR 126. The daily project trips were added to the existing traffic volumes for each highway/roadway segment and the volume to capacity (V/C) ratio was calculated. The roadway segment analysis with the project traffic is summarized in Table DR91-1. Trucks represent up to 8 percent of the daily traffic on SR 126 and as much as 20 percent of the daily traffic on SR 23 along the route. Based on the analysis, all roadway segments will continue to operate at LOS B or better. There would be no significant impact.

The roadways have sufficient capacity to also accommodate the additional potential peak soil import truck trips (estimated at a maximum of 100 trips). No impacts are expected.

Intersection Analysis

There are three signalized intersections along the proposed truck route between the quarry and the project site (excluding the interchange at SR 126 and Briggs, which was evaluated in the AFC). These include SR 126 at A, B, and C Streets in the City of Fillmore.

The City of Fillmore considers LOS D as the minimum acceptable LOS for City intersections along SR 126, except for the SR 126/A Street intersection, which has a minimum acceptable standard of LOS E. Current traffic data are not available for any of the intersections along the route. Based on the minimal number of peak hour project trips, it is unlikely that the additional project traffic would increase the LOS grade at any of the intersections. However, it is possible that the proposed project could result in a temporary impact as a result of the project truck trips traveling through these intersections during peak hours. Travel to and from the quarry would occur over approximately 22 days and would therefore be a short-term impact. It is recommended that, as part of the Construction and Demolition Transportation Management Plan (TMP), the number of trucks travelling through the intersections is minimized or scheduled to occur outside of peak hours.

Haul Truck Trips


Response: Attachment DR92-1 includes a revised construction traffic evaluation for MREC, which has been updated to reflect current fill material import plans and linear facility construction trips. This analysis was prepared for and provided to the Mission Rock Property Owners Association on October 14, 2016 to assist with their project review. This analysis updates and replaces portions of AFC Sections 5.12.2.1 and 5.12.2.2. A summary table is included, presenting average daily worker trips, soil import trips, and other truck delivery trips by month over project construction period.

Peak Trips for Water Line and Gen-tie Line



This technical memorandum presents an updated construction traffic impact analysis for the Mission Rock Energy Center (MREC) based on revised construction workforce and truck trip projections. This memorandum supplements the MREC Application for Certification (AFC) Section 5.12, and was prepared to provide updated information to the Mission Rock Road Property Owners Association (MRR POA) in support of their project review. California Energy Commission (CEC) Staff requested input on the MREC project from MRR POA in a letter dated September 27, 2016. This updated analysis will also be filed directly with CEC in the form of a Data Request response. The text below provides an updated version of portions of Section 5.12.2.1 and 5.12.2.2 of the MREC AFC.

Construction Traffic Generation (replaces portions of AFC Section 5.12.2.1)

The MREC AFC construction traffic analysis has been revised based on updated construction data including the anticipated number of delivery vehicles, haul vehicles, and worker trips. Estimated Average Daily Traffic (ADT) for each month of construction is presented in Attachment 1. This shows the variation in construction worker trips and truck trips based on planned activities during the various construction phases. Attachment 1 shows the peak month for construction traffic trips to the site will be Month 6, during which site civil improvement activities (soil import) will overlap with the beginning of plant construction activities. As a conservative analysis, the project trips were analyzed based on the peak month for combined workforce and truck trips projected during Month 6.

During Month 6, there will be 143 construction workers on-site per day. Based on experience with similar projects, it is conservatively estimated that 16 percent of the workforce will carpool with others, resulting in 120 round trips (120 arrivals and 120 departures). It is also conservatively assumed that all of the workforce arrival trips will occur during the morning peak hour and all of the workforce departure trips will occur during the afternoon peak hour.

During Month 6, there will be an average of 85 delivery/haul truck trips per day, including 61 soil import trips and 24 other delivery truck trips associated with site civil improvements and plant construction. It is estimated that the truck trips will be spread evenly throughout a 10-hour work day, resulting in 9 round trips per hour, including during the morning and afternoon peak hour. For purposes of this analysis, the truck trips were converted to passenger car equivalent (PCE) trips at a ratio of 1.5 passenger cars for each truck, consistent with the HCM 2010 guidelines. As shown in Revised Table 5.12.8, the project would generate a peak of 248 daily round trips, with 146 one-way trips occurring during each peak hour.

While the soil import process is expected to occur at a consistent rate over the 5-month soil import duration (61 loads per day, 22 days per month), it is possible there may be some variation in the daily trips. The maximum daily peak for soil import truck trips is not expected to exceed 100 loads per day.

There will be significantly fewer truck trips during the remaining construction phases. For example, Month 10 is representative for truck trips during the post site improvement plant construction phase,

during which 22 round trip truck trips per day are anticipated. Based on a 10-hour work day, the average would be approximately 2 round trip truck trips per hour.

The revised construction trip estimates for the peak month (Month 6) are presented in Revised Table 5.12-8.

Construction Traffic Distribution

The following assumptions were used to distribute construction traffic over the study area network:

Workforce Trips

- 60 percent of trips will come from Ventura, Oxnard, and communities to the west and south of the site via eastbound SR-126
- 40 percent of trips will come from Santa Paula, Santa Clarita, and communities to the east and south of the site via westbound SR-126

Truck Trips

- 20 percent of trips will come from Ventura, Oxnard, and communities to the west and south of the site via eastbound SR-126
- 80 percent of trips will come from Santa Paula, Fillmore, Santa Clarita, and communities to the east and south of the site via westbound SR-126, accounting for soil import trips coming this direction

Roadway LOS with Construction Traffic

The daily traffic volumes generated during the MREC peak construction period were added to the existing traffic volumes on each roadway segment and the V/C ratio was calculated. The roadway segment analysis with the project traffic is summarized in Revised Table 5.12-9. Based on the analysis, all roadway segments will continue to operate at an acceptable LOS. The study roadways have sufficient capacity to also accommodate the additional potential peak soil import truck trips (estimated at a maximum of 100 trips). No impacts are expected.

Intersection LOS with Construction Traffic

The MREC peak-hour traffic generated during the peak construction period was added to the existing turning movement counts at the study intersections. The results of the peak-hour LOS analysis with the project traffic is summarized in Revised Table 5.12-10. The study intersections will continue to operate at acceptable LOS with the MREC-added construction traffic during both peak hours. The study intersections have sufficient capacity to also accommodate the additional potential peak soil import truck trips.

Linear Facility Construction Impacts (Replaces AFC Section 5.12.2.2)

Natural gas will be provided via an approximately 2.4-mile-long new pipeline along Todd Road and the inactive Southern Pacific Railroad right-of-way to SCE’s Lines 404/406 west-southwest of the MREC site. Construction of the pipeline within existing streets (Shell Road) will not require complete public road closure, but may require periodic lane closures or may affect the available width of travel lanes. An encroachment permit will be obtained from the County for work that occurs within the public right-of-way. The lane closures could result in a temporary disruption of traffic flows. This roadway has little traffic and dead-ends at the Ventura County Jail boundary.

The proposed generator tie-line and recycled water pipeline will not be constructed along public roads; any roadway impacts will be limited to road crossings.

MREC construction within or across streets could temporarily affect emergency access and access to local land uses and transit. These impacts are anticipated to be less-than-significant and short-term, and will be further reduced with the implementation of the proposed Construction and Demolition Transportation Management Plan. The Transportation Management Plan will address potential street or lane closures.

The total workforce associated with linear facility construction is estimated to peak at 30 workers during Month 4 of construction. Offsite truck trips associates with linear facility construction are estimated to peak at 14 trips per day. The construction crews for the linear facilities will be staged in appropriate

areas adjacent to construction activities, and will not be traveling to and from the MREC site daily (linear construction workforce was not included in the on-site workforce numbers presented above). The construction-related trips will be dispersed among multiple locations, resulting in a minimal number of trips in any one location. These temporary impacts of this relatively small number of trips are less than significant.
