In accordance with the *Revised Scheduling Order* issued on January 31, 2017,¹ Mission Rock Energy Center, LLC (the “Applicant”) files this Status Report to inform the Committee on the progress of the Mission Rock Energy Center (“Project”) proceeding.

DISCOVERY

Since the filing of Status Report #7, the Applicant has completed its responses to all outstanding informational items identified in Staff’s Status Report No. 7, which were identified as needed to publish a complete Preliminary Staff Assessment.² The Applicant provided responses to those items as follows:

On March 15, 2017, the Applicant docketed the Federal Emergency Management Agency’s (“FEMA’s”) *Conditional Letter of Map Revision Based on Fill Comment Document* (“*Comment Document*”) for the Project. As set forth in the *Comment Document*, FEMA has determined that the Project, if built as proposed, would not be located in a Special Flood Hazard Area.

The Applicant has been diligently working with the Ventura County Air Pollution Control District (“VCAPCD”) and the San Joaquin Valley Air Pollution Control District (“SJVAPCD”) to finalize an emissions inventory and finalize modeling results in support of issuance of the Preliminary Determination of Compliance (“PDOC”). All issues have been resolved. Once the SJVAPCD completes the modeling, the VCAPCD will issue the PDOC.

The Applicant continues to work with Commission Staff towards publication of the Preliminary Staff Assessment.
