Subject: **RESPONSE TO REQUEST FOR EXTENSION OF COMMENT PERIOD ON THE PRELIMINARY STAFF ASSESSMENT (PSA)**

On December 19, 2017, the Santa Paula Alliance filed a request for the Committee to extend the comment period on the Preliminary Staff Assessment (PSA).¹ Energy Commission staff published the PSA on November 27, 2017.² The PSA comment period will close on January 26, 2018, 60 days after the PSA's publication date.³

The request is to extend the PSA comment period for an additional 90 days after January 26, 2018. The request is based on the impact of the fires in the vicinity of the Mission Rock Energy Center proposed site. The request is not a formal motion as the requesting persons and entities are not parties to the proceeding.⁴

The Committee is interested in hearing from the parties and other interested persons on whether the request should be granted. In addition, if the request were granted, how much additional time for comment should be allowed?

The parties are requested to submit such comments on or before January 9, 2018.
