In accordance with the *Second Revised Scheduling Order* issued on July 3, 2017 (TN #: 220008), Mission Rock Energy Center, LLC (the "Applicant") files this Status Report to inform the Committee on the progress of the Mission Rock Energy Center ("Project") proceeding.

On March 9, 2018, the Applicant submitted a *Notice of Suspension of Application for Certification* ("Notice"). Following the Committee's *Request for Comments on Applicant's Notice to Suspend Proceedings*², the Applicant identified the duration of suspension sought, including the conditions under which the proceeding should resume ("Response"). On March 23, 2018, Commission Staff and Intervenor Wishtoyo Foundation submitted responses regarding the Applicant's Notice and duration of suspension sought. Commission Staff stated that it did not object to the Applicant's Response. Intervenor Wishtoyo Foundation stated that the Committee should deny Applicant's request for suspension of the proceeding and instead issue an order terminating this proceeding.

On March 30, 2018, the Committee issued an order stating that Intervenor Wishtoyo Foundation's response will be treated as a motion to terminate under the Committee's regulations.⁶ The Applicant will be filing an opposition to the motion.
