**ORDER INSTITUTING
INFORMATIONAL PROCEEDING**

I. NATURE AND PURPOSE OF PROCEEDING

Executive Order B-37-16 requires state agencies to update temporary emergency water restrictions and transition to permanent, long-term improvement in water use by taking a number of specific actions. In particular, the Executive Order directs the California Energy Commission to certify innovative water conservation and water loss detection and control technologies that also increase energy efficiency.

The purpose of this Order Instituting an Informational Proceeding (OIIP) is to obtain information from interested stakeholders on the role of the Energy Commission in implementing Executive Order B-37-16, including the requirement that the Energy Commission certify innovative water conservation and water loss detection and control technologies that also increase energy efficiency. It is anticipated that this proceeding will cover, at a minimum, the topics described above, and may result in recommendations for the Commission to consider in a future rulemaking.

Accordingly, the Energy Commission hereby adopts an OIIP, whereby all stakeholders and other interested persons may participate in this proceeding.

II. APPOINTMENT OF LEAD COMMISSIONER

Commissioner McAllister is the designated Lead Commissioner for the OIIP. The Lead Commissioner and Executive Director are hereby authorized to take appropriate steps

under the law, including Public Resources Code Section 25210, to collect the information necessary to implement Executive Order B-37-16.

III. AUTHORITY

This action is taken pursuant to Public Resources Code Section 25210 and Sections 1220 et seq. of the California Code of Regulations, including specifically Section 1222(b), which provides that the Energy Commission may, upon its own motion, adopt an order to institute an informational proceeding.

IV. PROCEDURE GOING FORWARD

The Energy Commission hereby authorizes the Lead Commissioner and the Executive Director to conduct workshops and hearings to gather information and develop recommendations on the subject of this proceeding. The Lead Commissioner and Executive Director may solicit written comments and conduct one or more public workshops or hearings designed to gather and assess information by allowing interested stakeholders the opportunity to provide their opinions, recommendations, and any pertinent information that may assist the Commission in performing its duties.

The Lead Commissioner or Executive Director will issue a notice stating the scheduled time and room of each workshop or hearing held pursuant to this proceeding.

V. PUBLIC PARTICIPATION

The Energy Commission encourages public participation in its proceedings. Any person present at any workshop or hearing shall be afforded a reasonable opportunity to make oral comments on the subject of the proceeding. Written comments are also welcome and encouraged.

Comments in this proceeding may be submitted to the Energy Commission using the Commission's e-commenting feature by going to the Commission's webpage at <http://energy.ca.gov/appliances/rulemaking.html>, selecting the appropriate docket number, and clicking on the "Submit eComment" link.
