Notice of Energy Commission Workshop Regarding Barriers of Low-Income and Disadvantaged Communities to Energy Efficiency and Renewable Energy

The California Energy Commission will conduct a workshop to present the details of the draft "Senate Bill 350 Barriers Study" required by the Clean Energy and Pollution Reduction Act of 2015 (De León, Chapter 547, Statutes of 2015). This study addresses the barriers faced by low-income and disadvantaged communities to investing in energy efficiency and weatherization, installing solar photovoltaic and other renewable generating resources, and contracting opportunities for local small businesses. The draft study also highlights a range of potential solutions that have previously demonstrated success and may serve as the basis for developing recommendations to address these barriers in California.

Background

Governor Edmund G. Brown Jr. signed the Clean Energy and Pollution Reduction Act of 2015 (SB 350) on October 7, 2015. The bill establishes new energy efficiency and renewable electricity targets by 2030 to support California's long-term climate goal of reducing greenhouse gas emissions by 80 percent below 1990 levels by 2050.

The bill also finds that there is insufficient understanding of the barriers for low-income and disadvantaged communities to access energy efficiency investments, solar photovoltaic energy generation, weatherization, other forms of renewable generation, and contracting opportunities. For this reason, SB 350 directs the Energy Commission to complete and publish a study by January 1, 2017, on the following topics:

- Barriers to and opportunities for solar photovoltaic energy generation as well as barriers to and opportunities for access to other renewable energy by low-income customers.
- Barriers to contracting opportunities for local small businesses in disadvantaged communities.
- Barriers for low-income customers to energy efficiency and weatherization investments, including those in disadvantaged communities, as well as recommendations on how to increase access to energy efficiency and weatherization investments to low-income customers.

Agenda

This workshop will include presentations highlighting the identified barriers and potential solutions included in the draft study. The workshop may also include a panel discussion featuring representatives of the energy industry and environmental justice groups to respond to the barriers and solutions identified in the study.

In the workshop and public comments, the Energy Commission will ask for feedback on the following three questions:

- Are there any important barriers that are not identified in the draft study?
- Are there any important solutions that are not identified in the draft study?
- What would you identify as high-priority recommendations the final study should include to address these barriers?
