PROCEEDINGS BEGIN AT 8:38 A.M.

(The meeting was called to order at 8:38 a.m.)

HEARING OFFICER KRAMER: Let's get started here.

This is the Carlsbad Energy Center amendments. It's a continuation of the December 3rd Committee Status Conference, continued to this morning, December 10. My name is Paul Kramer. I'm the Hearing Officer for the Amendments Committee.

The main purpose of today's meeting is to conduct a closed session, which is what we announced at the last meeting. However, we also will be taking public comment, and we're going to do that right now.

Looking at -- in the room we have no members of the public. And I see that Intervenor Kerry Siekmann is the only other person on the line, the WebEx, who is not Commission Staff or the Committee.

Ms. Siekmann, it looks like you -- let me unmute you and ask if you wanted to say anything this morning before we go into closed session?

MS. SIEKMANN: Yeah. I would just like to say that -- and I've heard this from the Applicant before, too, that -- that they want -- they want as much information out there as possible. And I personally do not know Mr. Sarvey. I do not know if he's -- if his intentions are, you know -- I

1 don't know Mr. Sarvey.

2 But what I do know is that if someone is interested
3 in intervening and presenting good information for all of us
4 to know what's going to happen, then I support that. So I just
5 wanted to let the Committee know I would like -- I would not
6 want to be not allowed to present my information at -- at a
7 hearing, and I feel like that's what this country is all
8 about. So that's what I would like to say.

9 HEARING OFFICER KRAMER: Okay. Thank you.

10 MS. SIEKMANN: Uh-huh.

11 HEARING OFFICER KRAMER: There's nobody else on the
12 line to ask if they want to make a public comment, so we'll
13 close the public comment portion.

14 The Committee is going to adjourn to a closed
15 session pursuant to Government Code section 11126 subdivision
16 (c)(3), which allows a state body, including a delegated
17 committee such as this, to hold a closed session to deliberate
18 on a decision to be reached in a proceeding the state body was
19 required by law to conduct.

20 And we do not anticipate making any announcement of
21 an action at the end of the closed session, rather that would
22 come in the form of a written order. But we will keep the
23 WebEx line open until we return from closed session to
24 announce that it, if nothing else, that it has concluded. And
25 we expect that to be no later than 9:30. Certainly it will be

1 before 10:00 because we have the business meeting starting up,
2 and we need to clear the line so that the conference call for
3 that event can occur.

4 It occurs to me, I forgot to, for, I guess, for your
5 sake, Ms. Siekmann, and for the transcript, identify who's
6 present in the room, and that's, of course, myself Paul
7 Kramer, Commissioner McAllister is here, his Advisor Pat
8 Saxton. Commissioner Douglas is not presently here but she'll
9 be joining us for the closed session. Her Advisors, Jennifer
10 Nelson and Christine Store, are here. And then Kerry Willis,
11 the Staff Counsel, is also with us. So with that we will
12 adjourn to the closed session. And we --

13 MS. SIEKMANN: Thank you very much.

14 HEARING OFFICER KRAMER: Thank you.

15 (The Committee Convened a Closed Session from 8:44
16 a.m., until 9:31 a.m.)

17 HEARING OFFICER KRAMER: This is Paul Kramer -- are
18 we on the record, okay -- the Hearing Advisor. It was pointed
19 out to me that earlier I neglected to mention that Eileen
20 Allen, the Commissioners Technical Advisor for siting cases,
21 was also with us before we went into closed session.

22 In any event, the closed session has concluded at
23 about 9:30 a.m. And we took public comment before we went into
24 closed session. There are no results to report out of the
25 closed session regarding the Petition to Compel filed by Power

1 of Vision. We will be issuing a written order ruling on that
2 in the -- near future.

3 So with that, this meeting of the Carlsbad
4 Amendments Committee is adjourned. Thank you.
