**RE: Renewables Portfolio Standard Online System**

Dear Commissioners:

SDG&E respectfully submits the following comments on the Renewables Portfolio Standard Online System.

**CEC RPS Online System - Comments Related to the CEC Workshop on 10/6/2016**

- 1) Protected fields should not be able to be changed by others. As reference, someone from outside SDG&E was able to change SDG&E's address and save it.
- 2) Brief descriptions to the roles in the Assign Role screen should be added. Include view only if certain boxes are checked. If all boxes are checked, an error should come up to notify that you cannot be both a verification reporting agent & a certification attestant.
- 3) The WREGIS report will now need to be uploaded into the LSE's account before the LSE can attest to it. What is the turnaround time for this report to be uploaded, so that the LSE has time to attest to it to meet the CEC report timeline?
- 4) Will the system send an automatic email when a Notification has been sent?
- 5) It would prove more efficient to have the ability to be able to export the entire years' worth of claims on the Claims Eligibility Report rather than selecting & viewing one facility at a time. Is it possible to list all of the information for one facility separately even though it may have multiple WREGIS IDs?
- 6) Efficiencies would be increased by having drop lists (Home, Applications, Verification Reports, and Acct Mgmt) line up under the main tabs when a user hovers over them, making it easier for the user to select them.
- 7) Under 'New Application Facility', above 'Facility Mailing Address', it would increase efficiencies to have a box for "Same as Facility Address" and have the system automatically populate the address information.
