Pursuant to the Committee's May 26, 2016 Scheduling Order (TN# 211661) AltaGas Pomona Energy Inc. ("Applicant") submits this Status Report related to the pending application for Small Power Plant Exemption ("SPPE") for the Pomona Repower Project ("Project").

Applicant continues to evaluate the interconnection and transmission scenario as it relates to the recently completed storage project. Applicant also continues to evaluate market conditions on an on-going basis. At present, Applicant does not anticipate any near-term natural gas-fired Requests for Offers to accommodate the project as proposed, and Applicant continues to evaluate the best option for the facility in light of the storage project and market conditions. Given this information, and to avoid unnecessarily assigning Staff to this Project over the course of the next few months, Applicant respectfully requests that the Committee order that status reports going forward be due quarterly, with the next status report due on or before September 1, 2017.

In the meantime, if Applicant has any additional information regarding Project schedule and/or whether any modifications are required to the current project description, Applicant will notify Staff immediately.
