Energy Commission staff will consider these proposals, along with the data and information received through the Invitation to Participate, as they draft recommendations for the Energy Commission's consideration as part of the rulemaking process.

Any measures will be incorporated into California's Appliance Efficiency Regulations in Title 20 of the California Code of Regulations, sections 1601 – 1609, or into staff-issued white papers that will establish non-regulatory efficiency roadmaps for the identified appliance types. Proposal Format

The Energy Commission seeks proposals for efficiency measures that meet the following criteria:

- Efficiency improvements are technologically feasible and attainable.
- Efficiency improvements will reduce energy or water consumption growth rates.
- Appliances for which measures are proposed currently require a significant amount of energy or water on a statewide basis.
- The proposals shall not result in any added total costs for consumers over the designed life of the appliances (i.e., the measures are cost-effective).
- Proposals are supported by information or data in the Energy Commission's record for this proceeding or submitted as part of the proposal.

You may use the template, titled "Proposal For [Topic] Standards" for submitting their proposals for the Energy Commission's consideration, although other formats and information will also be accepted. The proposal template is available online at the bottom of the webpage at:

Submitting Proposals

To receive full consideration, please submit proposals to the Dockets Office by 5:00 p.m. (PDT) on September 1, 2017.

Proposals should be accompanied by a cover letter that references the specific appliance of interest and associated docket number in the subject line. The cover letter should be typed on the organization's letterhead and include the signature of an authorized representative.

Note that proposals and any other information submitted to the docket will be posted to the Energy Commission's web page for the proceeding. All information, attachments, and

associated contact information (e.g. address, phone, email, etc.) will become part of the viewable public record.
