Dear President Picker and Commissioners Florio, Sandoval, Peterman and Randolph,

On behalf of Poseidon Water, I urge you to reject the Proposed Decision and approve the Power Purchase Agreement (PPA) between San Diego Gas and Electric (SGD&E) and the Carlsbad Energy Center.

Poseidon Water is constructing the Carlsbad Desalination Project in partnership with the San Diego County Water Authority. When completed later this year, this facility will be the largest of its kind in the Western Hemisphere and will deliver up to 50 million gallons of drinking water a day. The Carlsbad Desalination Project will enhance water reliability for San Diego County by providing a locally controlled drought-proof source.

Desalination requires a stable supply of power 24 hours a day. Given the project's location adjacent to the Encina Power Station, we are keenly aware of the retirement of 965 MW by the end of 2017 to comply with once through cooling (OTC) regulations. A delay in approval of the PPA means that SDG&E will not have replacement capacity online by that time, potentially exposing the San Diego region to increased uncertainty with respect to power supply reliability.

Energy efficiency measures, demand response, renewable energy, and energy storage will clearly play an increasing role California's energy future alongside state-of-the art flexible gas-fired generation like the Carlsbad Energy Center. At a time when the SDG&E service area has lost the San Onofre Nuclear

Generating Station, and will soon lose the Encina Power Station, power supply reliability is a pressing consideration.

We note that Carlsbad Energy Center LLC has suggested an approach in which a project of reduced size might still be constructed in time for the retirement of the Encina Power Station. We recommend that you consider this proposal as soon as possible.
