On April 1-2, 2015, the Energy Commission Committee (Committee) assigned to conduct proceedings on the Petitions to Amend the Carlsbad Energy Center Project held Evidentiary Hearings on the Petitions to Amend. In reviewing the transcripts of the evidentiary hearings, Staff noted several corrections needed to the testimony, as follows:

From the Hearing Transcripts, April 1, 2015:

Visual Resources

- Page 43, line 1: change “CUP”, to “CECP” or “ACECP”
- Page 43, line 8: change “CUP”, to “CECP” or “ACECP”
- Page 50, line 5: change “TM” to “TN”
- Page 95, line 17: change “repeated” to “repeat it”

Noise and Vibration

- Page 115, line 24: change “noise in” to “noisy”
- Page 116, line 21: change “flexibility and the mitigation...” to “flexibility in the mitigation...”
- Page 117, line 3: change “mediation measures” to “mitigation measures”
- Page 120, line 1: change “remediation measures” to “mitigation measures”


From the Hearing Transcripts, April 2, 2015:

Land Use

- Page 28, line 22: change "MR. SARVEY" to "MR. KNIGHT"
- Page 29, lines 5 and 6: "...the Coastal Act does not prohibit non-industrial dependent, ~~or~~ rather non-coastal dependent industrial facilities..."
- Page 29, line 12: change "development is" to "development that is"
- Page 29, line 14: change "unless it is mitigated" to "unless as mitigated"
- Page 29, lines 18 and 19: "...and in this proceeding, staff's position ~~has also~~ is that the amended CECP is also consistent with Chapter 3 policies under the Coastal Act.
- Page 29, line 25: change "now" to "not"
- Page 30, line 3: change "cool" to "cooled"
- Page 30, line 5: change "three or four 13-D" to "30413(d)"
- Page 30, lines 6 and 7: "And the Coastal Commission's ~~three or four 13-D~~ 30413(d) report under the Coastal Act did ~~say the project to be consistent with~~ the Coastal Act not address coastal dependency.
