

Petition to Amend the Carlsbad Energy Center Project (07-AFC-06C)
Project Owner's Motion to Designate the I-5 Widening
FEIS/FEIR as an Exhibit for the Hearing Record

At the CECP Evidentiary Hearings, Staff's visual resources expert, Dr. William Kanemoto, provided testimony regarding the potential impacts of I-5 widening on the CECP. Portions of that testimony relied upon the Interstate 5 North Coast Corridor Project Final Environmental Impact Report / Environmental Impact Statement ("FEIS/FEIR") prepared jointly by Caltrans and the Federal Highway Administration. (TN-204130, pp. 46 – 48.) The FEIS/FEIR has not been introduced into the record. Project Owner docketed the FEIS/FEIR on April 24, 2015¹, because it is highly relevant to the testimony of Dr. Kanemoto (*Id.* at pp. 37 and 46 - 48), Kerry Siekmann of Terramar Association (TN-204131, pp. 247 – 48), Julie Baker of Power of Vision (*Id.* at p. 248, lines 1-8), Gary Barberio of the City of Carlsbad (*Id.* at pp. 26 – 28), and Robert Mason of CH2M Hill on behalf of the Project Owner. (TN-204130, pp. 90 – 91.)
