### **Purpose of Committee Conference**

Oral comments may be submitted by the public during the Committee Conference.

Following the end of the 30-day public comment period and consideration of comments from the parties and the public, the Committee may prepare an Errata to the PMPD describing any recommended changes to the document.

### **Intervenor and Public Comment Deadline**

The deadline for filing comments on the PMPD is **5:00 p.m. on July 9, 2015.** In order to assure that your comments are considered, they must be electronically uploaded to the e-filing system, or your e-mail received by the Docket Unit or your mailed written comment physically delivered on or before that time (postmarks do not count).

To facilitate the discussions at the committee conference, **the parties are requested to submit their comments on the PMPD on or before June 26, 2015.**

### **Public Adviser and Public Participation**

Members of the public are welcome to attend and offer comments at the Committee Conference. It is not necessary to be an Intervenor to participate in the public process.

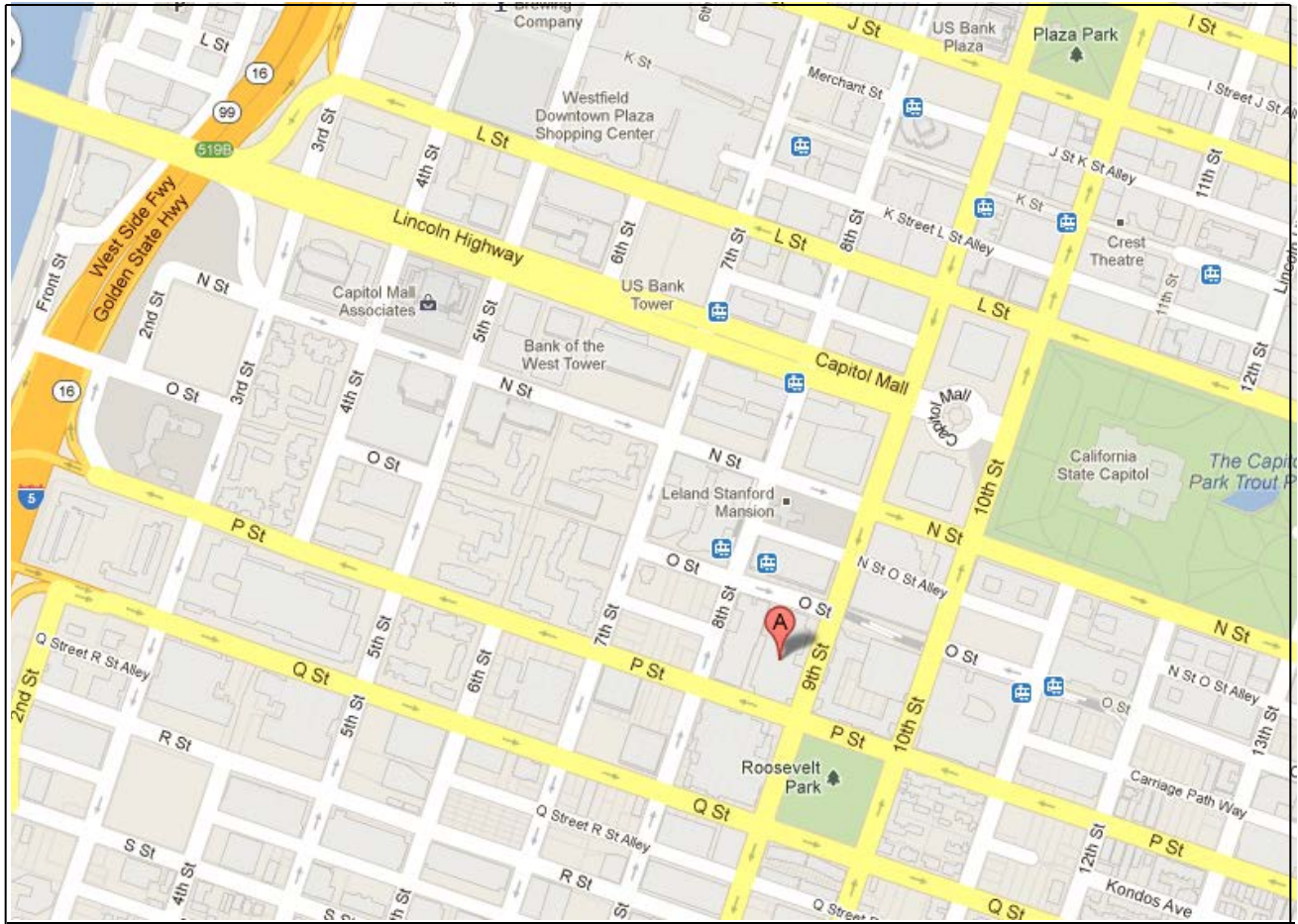
