Background

Public Resources Code Section 25301 requires the Energy Commission to prepare an *IEPR* every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The Energy Commission uses these assessments and forecasts to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety.

Senate Bill 1389 (Bowen and Sher, Chapter 568, Statutes of 2002) directs state government entities to use the information and analyses contained in the adopted *IEPR* to carry out their energy-related duties and responsibilities. During this *IEPR* proceeding, the Energy Commission

has coordinated closely with other agencies to ensure consistency in the underlying information used to develop this report.

The IEPR Lead Commissioner issued a scoping order on March 6, 2017, that identified topics to cover in the report. The focus of the *Draft 2017 IEPR* is the implementation of Senate Bill 350 (De León, Chapter 547, Statutes of 2015) which includes requirements to:

- Double energy efficiency savings in retail end uses by 2030.
- Increase the Renewables Portfolio Standard procurement target from 33 percent to 50 percent of retail sales by 2030.
- Encourage the electrification of the transportation system.
- Implement a long-term planning process for California's load-serving entities and local publicly owned electric utilities to cost effectively reduce greenhouse gas emissions with a diverse portfolio of supply-side and demand-side resources.
- Develop studies on the barriers and opportunities for low-income residents and disadvantaged communities in accessing energy efficiency, weatherization, renewable energy, and clean transportation options.

The Energy Commission held 32 public workshops and webinars between January 2017 and October 2017 on the topics identified in the scoping order. These workshops included 13 that were held jointly with other agencies. Several workshops and webinars addressed SB 350 implementation including:

- Developing targets to double energy efficiency savings by 2030.
- Increasing the flexibility of the electricity system to support increasing use of renewable resources and increasing electrification of the transportation sector.
- Planning for increased transportation electrification.
- Drafting guidelines for publicly owned utilities to use in developing their integrated resource plans.
- Addressing barriers that low-income and disadvantaged communities face in participating in and benefiting from a clean energy economy.

Related to these topics, other workshops addressed the advancement of distributed energy resources, strategic transmission investment planning to support new renewable development, climate adaptation and resiliency in the energy sector, and the reliability of the electricity system in Southern California.

Workshops also addressed the natural gas, transportation, and electricity demand forecasts. The Energy Commission plans to hold further workshops in November and December 2017 to update these forecasts.

The Energy Commission also held a workshop on renewable gas in response to Senate Bill 1383 (Lara, Chapter 395, Statutes of 2016).

Information from the workshops and public comments were key inputs in developing the *Draft 2017 IEPR*. All workshop documents, including agendas, background material, transcripts,
