**Notice to Extend the Comment Period for the *California Energy Demand 2018-2030 Revised Forecast***

On December 15, 2017, the California Energy Commission conducted a workshop to explore a range of perspectives on the future of electricity and natural gas demand in California over the next 12 years. The notice for the workshop stated that comments on the forecast are due December 28, 2017. As announced at the workshop, the Staff Report: *California Energy Demand 2018-2030 Revised Forecast* will not be available until early January, 2018; and so the due date for comments is being extended. **The Energy Commission expects to post the revised forecast on January 10 with Comments due on January 24.**
