Thank you for your participation today in the California Energy Commission hearing on two reconsideration petitions regarding an amendment to the Carlsbad Energy Center Project (ACECP). One of the issues raised for reconsideration was the fact that the Presiding Member's Proposed Decision (PMPD) was never sent to the California Department of Fish and Wildlife for review. You stated that the Department would normally review such a document, and would ideally have 30 days for such review.

The Energy Commission subsequently decided today to grant review for reconsideration of its decision any comments that your Department may want to file regarding the ACECP.
