## Notice of IEPR Commissioner Workshop on Publicly Owned Utilities Integrated Resource Plans

The California Energy Commission will conduct a workshop to discuss issues related to the development of guidelines for preparing, adopting, and submitting publicly owned utility (POU) integrated resource plans. This workshop is part of the *2017 Integrated Energy Policy Report* (IEPR) proceeding.

Chair Robert B. Weisenmiller is the Lead Commissioner for the 2017 IEPR. Other Commissioners at the Energy Commission may also attend and participate in the workshop. A quorum of Commissioners from the Energy Commission may be in attendance, but no votes will be taken. The workshop will be held:

### Background

California Public Resources Code Section 25301 requires the Energy Commission to prepare an IEPR every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. In addition, Senate Bill 350 (de León, Chapter 547, Statutes of 2015) (SB 350) requires qualifying POUs to adopt integrated resource plans (IRPs) at least once every five years. To facilitate their review, SB 350 allows the Energy Commission to adopt guidelines that will prescribe a process for

developing, submitting, and reviewing IRPs. Under SB 350, IRPs will inform state policy makers on the strategies and plans of POU to achieve California's renewable procurement and energy efficiency goals under various planning scenarios. In addition, when aggregated with information from the IRPs of load serving entities submitted to the California Public Utilities Commission (CPUC), these plans will allow state policy makers to track progress in meeting the state's electricity sector Green House Gas (GHG) emission reduction target.

To inform the discussion at this workshop, the Energy Commission plans to release a staff paper entitled *The Proposed Guideline Topics for Publicly Owned Utilities' Integrated Resource Plans* that describes the preliminary framework of the guidelines and solicits stakeholder input on staff's proposal. Staff proposes that guidelines include suggested and required integrated resource plan contents, provide requirements for submitting integrated resource plans to the Energy Commission for review and comment, and describe the process for correcting an integrated resource plan's deficiencies. The staff paper identifies a number of questions on specific issues related to POU IRPs and encourages parties to address these and other topics of interest or concern. A separate workshop, jointly conducted by the Energy Commission and CPUC, on establishing 2030 greenhouse gas emission reduction targets for IRPs will be held in the morning starting a 9:30 a.m. A separate public notice addresses the morning workshop.
