Dear Mr. Kimball,

As we discussed on the phone this morning, my draft letter recommending a grant of confidentiality for the contract between WC-3 and NRG for DCBP services for the Carlsbad Energy Center Project was not accepted by our Executive Office. Rather than issuing a rejection letter in response to your Application for Confidential Designation, I recommended
