## Notice of IEPR Staff Webinar on Standardized Tables and Instructions for Publicly Owned Utility Integrated Resource Plans

The California Energy Commission staff will conduct a webinar to discuss the proposed standardized tables for use by specified publicly owned utilities (POUs) for submitting data to the Energy Commission as part of integrated resource plans. This webinar is being conducted as part of the *2017 Integrated Energy Policy Report (IEPR)* proceeding. Chair Robert B. Weisenmiller is the Lead Commissioner for the 2017 IEPR. ### Background

California Public Resources Code Section 25301 requires the Energy Commission prepare an IEPR every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. In addition, Senate Bill 350 (de León, Chapter 547, Statutes of 2015) requires qualifying POUs to adopt integrated resource plans (IRPs) at least once every five years.

Under Public Utilities Code 9622, the Energy Commission "...may adopt guidelines to govern the submission of information and data and reports needed to support the Energy Commission's review of the utility's integrated resource plan." On May 15, 2017, the Energy Commission released draft *Publicly Owned Utility Integrated Resource Plan Submission and Review Guidelines* for discussion at the May 25 IEPR Workshop. Among other things, the guidelines provide data reporting requirements to the Energy Commission, including standardized tables. At the end of May 2017, the Energy

Commission released draft standardized tables and instructions for public review and comment. These explain what data must be submitted with the POU integrated resource plan as well as the required format of the data.

## **Agenda**

The webinar will be a discussion of the format and content of the draft standardized tables and instructions, and will be followed by a public comment period. The webinar will conclude with a staff description of the process and schedule for adopting final tables and instructions.

The webinar will provide an opportunity for stakeholder discussion on the content of the draft standardized tables and instructions, and to raise questions/concerns about them.

## **Public Comment**

**Oral Comments:** Oral comments will be accepted during the webinar. Any comments may become part of the public record in the Energy Commission's IEPR proceeding.

**Written Comments:** Written comments must be submitted to the Dockets Unit by 5:00 p.m. on June 14, 2017. All written comments will become part of the public record of this proceeding.
