**NOTICE OF RECEIPT
PETITION TO AMEND
THE CALIFORNIA ENERGY COMMISSION DECISION FOR THE
ORANGE GROVE POWER PROJECT (08-AFC-4C)**

On May 20, 2014, Orange Grove Energy, L.P. filed a petition with the California Energy Commission (Energy Commission) requesting to modify the Final Decision for the Orange Grove Power Project (OGPP). The simple-cycle, natural gas-fired, electricity-generating, 96-megawatt facility was certified by the Energy Commission in its Decision on April 8, 2009, and began operation on June 17, 2010. The facility is located in the unincorporated area of Pala, in San Diego County, California.

DESCRIPTION OF PROPOSED MODIFICATION

The modifications proposed in the petition would revise Energy Commission Conditions of Certification (**AQ-SC 1** through **5**, **Waste-6**, **Soil & Water-3** and **10**, **Noise-1**) and add new conditions (**AQ-SC12**, **BIO-15** and **16**, **Soil & Water-14**, **15**, and **16**, **PAL-8** and **9**, and **TRANS-6** and **7**) to allow OGPP to obtain water from a nearby San Diego Gas & Electric Company well. According to the petition, this modification is needed to address water truck complaints from neighbors near the water supply location, and because of possible wildfires that may threaten the availability of the water pickup station and truck route roads.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality and on public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and a determination on whether the facility, as modified, would remain in compliance with applicable laws, ordinances, regulations, and standards (20 Cal. Code of Regs., § 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving, denying, or modifying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

The amendment petition has been posted on the Energy Commission's webpage for this facility at <http://www.energy.ca.gov/sitingcases/orangegrovepeaker>. The Staff Analysis, when completed, will also be posted on this webpage.

This Notice of Receipt is being provided to interested parties and property owners adjacent to the facility site. This Notice has been mailed to the Commission's facility mail list and sent electronically to the facility listserv. The listserv is an automated Energy Commission e-mail system by which information can be distributed to all parties who have subscribed. You can subscribe from the Commission's webpage for this

facility, cited above, by scrolling down to the shaded blue box on the right side of the project's webpage, labeled "Subscribe," and providing the requested contact information.

Any person may comment on the petition. Those who wish to comment on the petition can use the Energy Commission's e-commenting feature as follows: Go to the Energy Commission's webpage for this facility and click on the "Submit e-Comment" link. In the form, provide the required information—your full name, e-mail address, the comment Title, and either a comment or an attached document. The comment Title should be "[Your Name]'s Comments re: Orange Grove Power Project Petition." Type your comments into the "Comment Text" field, or upload and attach a document with your comments. The maximum upload file size is 10MB, and only .doc, .docx, or .pdf attachments will be accepted. Enter the CAPTCHA that is used to prevent spamming. Then click on the "Agree and Submit your Comments" button to submit your comments to the Energy Commission Dockets Unit for review. When your comments are approved and docketed, you will receive an e-mail with a link to them.
