
**Project Description:** Orange Grove Energy Power Project is a 96 MW simple cycle power plant located in the unincorporated area of northern San Diego County, approximately 3.5 miles northeast of Interstate 15 on State Route 76, approximately 2.0 miles west of the community of Pala.


**Modification Description:** Petition to allow Orange Grove Energy, L.P. to restore worn parts of the emission control systems and to optimize the design of system components using like-kind part replacement where needed to improve resistance to wear and long-term reliability;

On July 13, 2016, the California Energy Commission approved the above-described project change pursuant to a regulatory program certified by the California Secretary of Resources under Section 21080.5 of the California Public Resources Code.

1. The project will not have a significant effect on the environment.
2. Mitigation measures were made a condition of approval of the project.
3. A statement of Overriding Considerations was not adopted for the project.

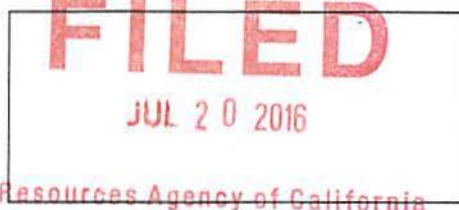
