GWF Energy, LLC, the owner/operator of the GWF Tracy Combined-Cycle Power Plant project, located in an unincorporated portion of San Joaquin County immediately southwest of Tracy, and approximately 20 miles southwest of Stockton, has submitted a petition to transfer operational control of the GWF Tracy Combined Cycle Power project to Star West Generation Management Company, an affiliate of GWF Energy, LLC. GWF Energy, LLC will continue to be the party responsible for compliance with the Energy Commission's conditions of certification for the project. A representative of the new project operator has provided a declaration, under penalty of perjury, that Star West Generation Management Company agrees to comply with the conditions of certification in the Energy Commission's Decision for the GWF Tracy Combined Cycle Power project.

STAFF RECOMMENDATION

Staff has reviewed the petition, finds that it complies with the requirements of Title 20, section 1769 (b) of the California Code of Regulations, and recommends approval of the change in operational control.

CONCLUSION AND ORDER

The California Energy Commission hereby adopts the staff's recommendation and approves the transfer of operational control from GWF Energy, LLC to Star West Generation Management Company.


