As part of the June 29, 2006 Business Meeting, the Energy Commission will consider adopting revisions to the *Guidebook* for the Emerging Renewables Program (Guidebook). The previous *Guidebook* was adopted in January 2006. The California Energy Commission's Renewables Committee (Committee) recommends these *Guidebook* revisions pursuant to Public Resources Code section 25747, which authorizes the Energy Commission to adopt substantive changes to the *Guidebook* upon providing ten days written notice. Changes shall take effect once approved by the Energy Commission at a publicly noticed meeting.

The Committee proposes the following changes to the Guidebook:

- Effective July 1, 2006, maintain the current rebate level for wind systems to \$2.50/watt for the first 7.5 kW of capacity and \$1.50/watt for incremental capacity above 7.5 kW and less than 30 kW.
- Other changes and updates to provide clarification.
