Subject: HECA (08-AFC-8A) - Additional Workshops and Committee Conference

Thank you to all of the members of the CEC and DOE staff who worked to make last week's workshops productive. While a number of issues remain unresolved, the exchange of information at and leading up to the workshops helped to narrow the number and scope of such issues. The workshops also provided ample opportunity for interveners and members of the public to express their views on the project.

Following up on commitments made by the CEC to hold additional workshops and a Committee Conference in late October or early November, given the number of parties involved, we suggest that we begin immediately to identify and confirm dates. We therefore ask that agency staff and the Committee identify proposed dates as soon as possible.

We also ask that the Committee issue a revised Scheduling Order based on information provided in the most recent status reports. Applicant had assumed that scheduling issues would be discussed at the Committee Conference initially proposed for last week. Now that the Conference has been postponed, we think it is important that the Committee convey its expectations regarding schedule (particularly release of the FSA/FEIS) prior to the re-scheduled Conference to provide adequate notice to the parties.
