**Background**

On July 31, 2008, Hydrogen Energy International, LLC filed an AFC seeking authority to construct and operate the HECA project, an integrated gasification combined-cycle (IGCC) power generating facility rated at a nominal gross generating capacity of 390 megawatts (MW). The proposed HECA project would be located near the unincorporated community of Tupman in western Kern County, California, seven miles west of the city limit of Bakersfield. Ownership of the project changed to Hydrogen

Energy California, LLC (Applicant) on September 22, 2010. On May 2, 2012, Applicant filed the present Amended Application for Certification.

The project would be fueled by a combination of coal and petroleum coke, and would inject its emissions of carbon dioxide (CO<sub>2</sub>) into an underground location for carbon sequestration. The location was to have been the Elk Hills Oil Field. However, circumstances have resulted in Applicant seeking a different location for carbon sequestration.

On July 3, 2015, after a hearing on a motion brought by intervenors Sierra Club, HECA Neighbors, and Association of Irrigated Residents to terminate the AFC, and having considered a request by Applicant for a six-month suspension of the AFC, the Committee issued an order denying the motion to terminate and granting a six-month suspension with conditions. That suspension ended on January 6, 2016. Applicant filed a Request to Reinstate the AFC on November 30, 2015. In the Energy Commission Staff response dated December 15, 2015, Staff recommended that the AFC be terminated. The Committee is considering both parties' requests as motions pursuant to California Code of Regulations, title 20, section 1211.5 (formerly section 1716.5) and so notified the parties in a memorandum dated December 22, 2015.

### **Purpose of the Hearing**

The Committee will conduct the hearing to hear oral argument on Applicant's Motion to Reinstate the AFC and on Staff's Motion to Terminate the AFC. The Committee asks that the parties be prepared to offer oral argument on the Motions and to provide factual support, such as testimony, documents, or other evidence, for any assertions the parties are relying upon to support their positions in this matter. In addition, the Committee may ask the parties for information regarding the present status of the case.

### **Closed Session**

The Committee may temporarily adjourn into closed session to deliberate pursuant to Government Code section 11126.

### **Public Participation and Public Adviser**

Members of the public are welcome to attend and offer comments at the hearing. It is not necessary to be an intervenor to participate in the public process. 
