**INTRODUCTION**

This Petition seeks to transfer ownership of the Final Decision for the Palmdale Hybrid Power Project (PHPP), 08-AFC-9, from the City of Palmdale (City) to Palmdale Energy, LLC. Palmdale Energy, LLC is a wholly owned subsidiary of Summit Power Projects Holdings, LLC (SPPH). SPPH is owned by Summit Power Group, LLC a long standing developer of energy projects in the US. This Petition is prepared pursuant to 20 CCR 1769 (b). Section 1769 (b) requires this Petition to include:

- (A) a discussion of any significant changes in the operational relationship between the owner and operator;
- (B) a statement identifying the party responsible for compliance with the commission's conditions of certification; and
- (C) a statement verified by the new owner or operator in the same manner as provided in Section 1707 that the new owner or operator understands the conditions of certification and agrees to comply with those conditions.

The remainder of the Petition sets forth information responsive to these requirements.

## **CHANGES IN OPERATIONAL RELATIONSHIP**

On April 30, 2015, Palmdale Energy, LLC closed on a purchase and sale agreement with the City of Palmdale for the purchase of all rights, licenses, permits, options, etc. in existence for the PHPP. Palmdale Energy, LLC is filing on April 30, 2015, a Petition To Amend the PHPP to eliminate the solar component of the project and to upgrade the turbines to fast-start capability, replace wet cooling with dry cooling, and to eliminate the zero liquid discharge system.
