NOTICE OF PUBLIC SITE VISIT, ENVIRONMENTAL SCOPING MEETING AND INFORMATIONAL HEARING, AND COMMITTEE ORDER

On April 30, 2015, Palmdale Energy, LLC (project owner or Petitioner), a solely-owned subsidiary of Summit Power Project Holdings, LLC, submitted a Petition to Amend (Petition) to the California Energy Commission seeking permission to make changes to the Final Decision for the Palmdale Hybrid Power Project (08-AFC-09C) (PHPP). The Petition proposes to change the approved PHPP from a 570 megawatt (MW) hybrid combined-cycle and solar trough power plant to a natural-gas-fired 645 MW combined-cycle power plant. Specifically, the Petition proposes to eliminate the solar component and replace the combustion turbine technology with fast-start flexible technology, as well as requests the project name be changed from Palmdale Hybrid Power Project to Palmdale Energy Project (PEP). The changes are described in greater detail later in this notice.

The PEP site is located in the City of Palmdale, bounded by Sierra Highway to the west, East Avenue M (Columbia Way) to the north, and U.S. Air Force Plant 42 on the south and east. The address is 950 East Avenue M, Palmdale, California 93550 (TN 205394-1).

Background

The Energy Commission issued a Final Decision approving the construction and operation of the PHPP on August 10, 2011 (Order No. 11-0810-09, the "Final Decision," 08-AFC-09) (TN 61876). Construction of the approved PHPP has not begun. Under the 2011 Final Decision, the project would be a 570 MW hybrid of natural-gas-fired combined-cycle generating equipment integrated with solar thermal generating equipment to be developed on an approximately 333-acre site. The combined-cycle equipment would utilize two natural-gas-fired combustion turbine generators (CTGs), two heat recovery steam generators (HRSGs), and one steam turbine generator (STG). The planned solar thermal equipment involved arrays of parabolic collectors for heating a high-temperature working fluid. The hot working fluid would be used to boil water to generate steam. The combined-cycle equipment would be integrated thermally with the solar thermal generating equipment at the HRSG and both would have used the single STG.

On April 30, 2015, the project owner filed a Petition to modify the PHPP by renaming the project, eliminating the solar energy component, and reconfiguring the two-on-one combined-cycle power block to incorporate new gas turbine technology (TN 204459). On July 20, 2015, the Petitioner filed a Revised Petition to Amend, which includes all of the information provided in the original Petition and supplemental information that was unavailable at the time of the original submittal (TN 205394-1).

Amended Project Description

The amended project would consist of natural-gas-fired combined-cycle generating equipment to be developed on an approximately 50-acre site in the northern portion of the City of Palmdale. The proposed combined-cycle equipment utilizes two Siemens SGT6-5000F natural-gas-fired CTGs, two HRSGs, and one STG.

Project construction would last approximately 25 months. If the Petition is approved, commercial operation would commence approximately in summer 2019.

Purpose of the Environmental Scoping Meeting and Informational Hearing

The Energy Commission considers the relevant engineering and environmental aspects of the proposed amendment under the California Environmental Quality Act (CEQA). The Environmental Scoping Meeting and Informational Hearing scheduled in this Notice provides an opportunity for members of the community in the project vicinity to be introduced to the Energy Commission Committee and Hearing Officer assigned to oversee this proceeding, obtain information on the Energy Commission's siting review process and proposed project, identify areas of environmental concern to be addressed during the environmental review of the amendment, offer comments, and view the project site. The project owner will explain its plans for developing the project and the related facilities. Staff will explain the administrative licensing process and its role in reviewing the Petition. The Hearing Officer will explain the role of the Committee and the Public Advisor will explain how her office can offer assistance to the public.

ORDER REGARDING PROPOSED SCHEDULE AND ISSUE IDENTIFICATION REPORT

To assist participants in understanding the currently proposed project, Petitioner and Staff shall each file a proposed schedule for conducting the amendment process, and Staff shall file an Issue Identification Report (Report) summarizing any potential issues. The proposed schedules and Report shall be filed no later than 3 p.m. on November 10, 2015. These documents will be available for review at:

At the Environmental Scoping Meeting and Informational Hearing, the parties shall indicate whether anticipated data responses would resolve issues of concern that may be raised in Staff's Report.


