MOTION TO TERMINATE
THE CALIFORNIA ENERGY COMMISSION CERTIFICATION FOR THE
WATSON COGENERATION STEAM AND ELECTRIC RELIABILITY
(5TH TRAIN) PROJECT (09-AFC-1C)**

On June 15, 2015, the Watson Cogeneration Company (Watson) filed a letter with the California Energy Commission (Energy Commission) stating that it no longer intends to construct the Watson Cogeneration Steam and Electric Reliability (5th Train) Project. Efforts to commercialize the project were unsuccessful due to the poor regulatory and economic environment for Combined Heat and Power facilities in California.

The Watson Cogeneration facility 5th Train is a nominal 85 MW combustion turbine generator (CTG), with a single-pressure heat recovery steam generator (HRSG) to provide additional process steam to the BP Carson refinery, to the existing cogeneration facility owned by Watson. The 5th Train was certified by the Energy Commission in its Decision on April 12, 2012, and has not been constructed. The existing Watson Cogeneration facility is located in the City of Carson, in Los Angeles County, California.

The Energy Commission will provide public notice of the business meeting when this Motion to Terminate will be concluded. This Notice of Receipt has been mailed to the Commission's facility mail list of interested parties and property owners adjacent to the facility site. It has also been e-mailed to the facility listserv. The listserv is an automated Energy Commission e-mail system by which information about this facility is e-mailed to parties who have subscribed.
