WITH DIMENSIONS AND ALL APN NUMBERS FROM THE FREEWAY TO THE
PROJECT (BLM SHOULD HAVE THIS ON FILE) I WOULD ALSO LIKE TO KNOW
HOW THEY COULD GRANT THIS EASEMENT WITHOUT CONTACTING PRIVATE
PROPERTY OWNERS FOR THEIR INPUT ? I WOULD ALSO LIKE TO RECEIVE THE
LATEST SITE PLAN FOR THIS PROJECT WITH PROPOSED FENCING, RIGHT OF
WAY BOUNDARY AND BUFFER ZONES, AS ALL THESE ITEMS AFFECT MY
PROPERTY. I RECEIVED COMMENTS FROM MARY DYAS FROM THE ENERGY
COMMISSION IN WHICH SHE SAID THE PROJECT ALREADY RECEIVED ENERGY

SHIFTED IT TO THE EAST UNTILL THE AIRPORT HAD OBJECTIONS AND THEN
