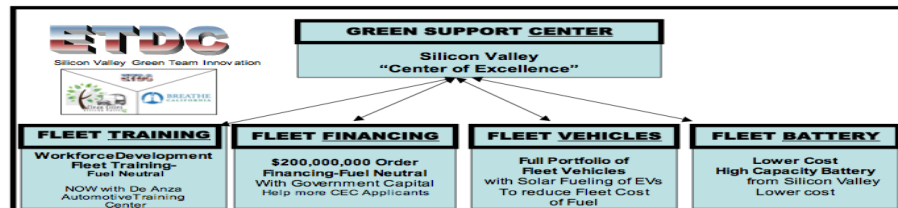

We need your assistance on the proposed "Center of Excellence" program considered by the CEC in the last two years investment programs.

The Silicon Valley Green Team, a triad of Silicon Valley Clean Cities (DOE), 100 year old Breathe California and our 8-year-old **Electronic Transportation Development Center** has focused on and prepared for this Center of Excellence opportunity for over two years and believe the basic structure of what we have developed in Silicon Valley has tremendous value to California. We provided a *47 page booklet explaining our resources, technology, training, financing and programs. We believe our organizational, teaming work and multiple Industry Centers should still be reconsidered under different or multiple CEC programs.

Our Silicon Valley Green **Fleet Centers** encourage (1) implementation of fuel neutral alternative fuel vehicles (light and heavy duty), (2) provides improved innovative infrastructure in solar & battery, (3) promotes Silicon Valley Vehicle Technology innovation, (4) ensures Green Transportation Workforce Development Training, and (5) provides \$200,000,000 in private project funding to add to the CEC grants to help the California Fleet Industry. We had expressed our innovative organization graphically like:



We would appreciate guidance of how to "repackage" the resources we identified and brought together over the last 2-year period.
