

Notice Requesting Public Comments on Staff Draft Renewables Portfolio Standard Eligibility Guidebook, Eighth Edition

California Energy Commission staff is seeking written public comments on the Staff Draft Renewables Portfolio Standard Eligibility Guidebook (RPS Guidebook), Eighth Edition. The RPS Guidebook describes the eligibility requirements and process for certifying renewable resources as eligible for California's RPS and describes how the Energy Commission verifies compliance with the RPS. The RPS Guidebook is revised periodically to reflect statutory, market, and regulatory developments and to respond to lessons learned through implementing the RPS program.

On January 28, 2014, staff held a Scoping Workshop to solicit public comments on possible revisions to the RPS Guidebook, Seventh Edition. Based on the public comments received, staff is proposing revisions as shown in the Staff Draft RPS Guidebook, Eighth Edition (Publication No. CEC-300-2015-001-ED8-SD). The proposed revisions include both substantive and nonsubstantive changes. Nonsubstantive changes include revisions to various sections in the quidebook to improve clarity and reduce duplication. Substantive changes are proposed related to the following topics:

- New eligibility requirements for RPS-certified multifuel facilities related to nonrenewable energy resource allowances
- Revised definition of biomethane dedicated pipeline to include functionally dedicated pipeline with new reporting requirements
- Revised definition of station service
- Revised definition of prime generating equipment for repowered facilities
- Modification of how a facility's eligibility date is determined
- Allowance of new method to determine the amount of incremental generation using rated facility improvements for hydroelectric facilities only
- Use of postmark date as "received" date for submissions
- Extend the record retention period to five years

In addition, the Staff Draft RPS Guidebook incorporates changes adopted by the Energy Commission as a result of three separate resolutions approved over the last nine months. These changes include:

- Process to request a time extension for applying for RPS certification; adopted on April 22, 2014, via Resolution No. 14-0422-11.
- Process and criteria to request creation of retroactive renewable energy credits not tracked in the Western Renewable Energy Generation Information System, and

- extending the use of the Energy Commission's Interim Tracking System until December 31, 2013; adopted on October 7, 2014, via Resolution No. 14-1007-10.
- Revisions to the requirements for certifying a small hydroelectric generation unit with a
 nameplate capacity not exceeding 40 megawatts that is operated as part of a water
 supply or conveyance system pursuant to new legislation (Assembly Bill 1478, Statutes
 of 2014, Chapter 664, Section 8); adopted on November 17, 2014, via Resolution No.
 14-1117-14.

Staff will consider written public comments on the proposed changes to the *RPS Guidebook*, incorporate any needed revisions, and then present the final draft of the guidebook for consideration by the full Commission at a regularly scheduled business meeting. Public Resources Code Section 25747 authorizes the Energy Commission to approve substantive changes to the guidebook upon providing ten days public notice. Changes take effect once approved at a publicly noticed meeting.
