STATUS REPORT #15 FOR THE SUN VALLEY ENERGY PROJECT (05-AFC-3)

Dear Mr. Worl,

Pursuant to the terms of the Commission's Order Suspending Proceeding dated June 20, 2012, Valle Del Sol Energy, LLC submits Status Report #15 for the Sun Valley Energy Project. The Sun Valley Energy Project (SVEP) is a 500-megawatt natural gas-fired peaker plant that will be located in the City of Menifee, California. The site is located on 50 acres of former farm land 30 yards southwest of the Valley Substation and will feature five General Electric LMS-100 gas turbines.

Valle Del Sol believes that SVEP represents an ideally-sited opportunity to add peaking generation to efficiently integrate renewable energy to the Los Angeles basin grid as it becomes necessary. We continues to track Assembly Bill 1318 (AB 1318, Perez, Chapter 285, Statutes of 2009) which requires CARB, in consultation with the ISO, CEC, CPUC and the SWRCB to provide a report to the Governor regarding their assessment of the electrical system reliability needs of the South Coast Air Basin (SCAB) and recommendations for the most effective way to meet those needs. A status report was issued by CARB on June 22, 2012 which indicates that they have conducted a local capacity area requirements study and a regional requirements study. The results of these studies are currently under review, however, it is evident that they are faced with significant challenges regarding grid reliability. Valle Del Sol is hopeful that the final study results will drive changes essential for new power plants with regards to emission offsets. We have demonstrated ownership of all required VOC ERCs, however, are still challenged by the lack of available PM₁₀ and SO_x ERCs that is affecting the entire SCAQMD region. With no other issues identified in the SCAQMD Final Determination of Compliance or in the CEC's Preliminary Staff Assessment, we believe that SVEP is one of the viable solutions to these challenges. We will continue to track the results of these studies and plan to participate in the public workshop identified in the tentative schedule published in CARB's status report.

We greatly appreciate the Commission's support and we will continue to provide you with updates on any changes relating to the progress of the SVEP.
