Pursuant to the terms of the Commission's Order Suspending Proceeding dated June 20, 2012, Valle Del Sol Energy, LLC submits Status Report #24 for the Sun Valley Energy Project. The Sun Valley Energy Project (SVEP) is a 500-megawatt natural gas-fired peaker plant that will be located in the City of Menifee, California. The site is located on 50 acres of former farm land 30 yards southwest of the Valley Substation and will feature five General Electric LMS-100 gas turbines.

Valle Del Sol met with Chris Davis and Keith Winstead on April 9, 2013 and discussed the benefits of the project and its location. Southern California Edison has informed us that the facility re-study will be completed by May 18, 2013. We will be submitting a letter to the Commission requesting an extension to our suspension and look forward to working with the Commission to find a solution that will allow the SVEP to succeed.
