

Subject: **SAN GABRIEL GENERATING STATION PROJECT (07-AFC-2) STATUS REPORT 3**

Pursuant to the Committee Scheduling Order dated July 12, 2007, the following is staff's Status Report 3 for the proposed San Gabriel Generating Station (SGGS) Project.

Current Issues and Activities for Resolution

Staff continues to analyze the Application for Certification (AFC) for the proposed SGGS project. Staff is awaiting information regarding an applicant-proposed blend of groundwater with reclaimed water that will be used for the both inlet air cooling and steam-cycle makeup at the SGGS project. The applicant has indicated staff will receive this information in early 2008.

The City of Rancho Cucamonga provided comments on the AFC. These comments included a discussion regarding the need for a local conditional use permit, approval of a variance for the two boiler stacks which exceed the height limit, a review of the proposed project by the Engineering, Building & Safety, and Fire Departments, and design standards recommendations. The City recommends that additional review to determine if the proposed project is consistent with the City's standards is necessary. Staff continues to work with the City and the applicant to address local ordinances, regulations and standards.

The schedule has been affected by the South Coast Air Quality Management District's (SCAQMD) delay in issuing a Preliminary Determination of Compliance (PDOC). Additional delays in the district's process indicate the PDOC may not be issued sooner than March 2008. Staff will continue to work closely with the SCAQMD to support the processing of the SGGS application and analysis of potential air quality impacts.
