Pursuant to terms of the Committee Order Granting Continuance issued on December 10, 2009, applicant RRI Energy, hereby submits this Status Report #3 for San Gabriel Generating Station (SGGS).

As discussed in the previous filing, a major impediment before the SGGS continues to be the current state of available particulate matter or PM₁₀ credits within the South Coast Air Quality Management District (SCAQMD). RRI Energy continues to follow the status of the issue. We believe the proposed location of the SGGS is ideally suited for the facility and would enable the SGGS to provide power to a region currently facing new generation constraints. Ultimately, the situation has remained relatively unchanged since SGGS Project Suspension Status Report #2 was filed last month. RRI Energy looks forward to providing the Committee any changes or potential changes in circumstances which may affect the SGGS project moving forward.
