Pursuant to the terms of the Committee Order Granting Continuance issued on July 16, 2010, applicant San Gabriel Power Generation, LLC (SGPG, LLC) a subsidiary of now GenOn Energy Inc., hereby submits this Suspension Status Report #4 for the San Gabriel Generating Station (SGGS).

As discussed in applicant's June 10, 2010, Request for Additional Project Suspension, RRI Energy and Mirant Corporation publicly announced a potential merger. The merger was subsequently completed on December 3, 2010, merging RRI Energy and Mirant Corporation into GenOn Energy Inc. (GenOn Energy) one of the largest independent power producers in the United States.

Additionally, as reported in our previous status reports, the current situation in the South Coast Air Basin has remained unchanged. The area remains emission reduction credit constrained, and a legislative solution has yet to present itself. GenOn Energy continues to monitor the issue in the South Coast Air Quality Management District and remains committed to helping southern California meet its energy needs. GenOn Energy will provide the Committee with any changes or potential changes in circumstances which may affect the SGGS project.
