SAN GABRIEL POWER GENERATION, LLC SUSPENSION STATUS REPORT NUMBER 15

In accordance with the Order Suspending Proceeding dated May 15, 2012 ("Order"), the applicant in this proceeding, San Gabriel Power Generation, LLC ("San Gabriel"), submits its suspension status report number 15. The Order instructed San Gabriel to file and serve monthly status reports beginning January 2, 2013, and continuing every thirty days thereafter.

San Gabriel filed an application for certification for the San Gabriel Generating Station, a 696 megawatt natural gas-fired electricity generating facility ("San Gabriel Project") to be located at the site of an existing power plant in Rancho Cucamonga, California, within the jurisdiction of the South Coast Air Quality Management District ("SCAQMD"). San Gabriel requested the current suspension of this proceeding due to permitting difficulties associated with the unavailability within the South Coast Air Basin of certain emission offsets needed to satisfy applicable SCAQMD rules. Those permitting difficulties still exist and emission offsets are still not available for the San Gabriel Project.

As of the date of its last filing in this proceeding, San Gabriel was an indirect, wholly owned subsidiary of GenOn Energy, Inc. Effective December 14, 2012, GenOn Energy, Inc. completed a merger with NRG Energy, Inc. ("NRG"). As a result of the merger, San Gabriel is now an indirect, wholly owned subsidiary of NRG. San Gabriel will submit updates to the proof of service list to reflect changes in the contact information for San Gabriel's representatives. NRG is continuing to assess the San Gabriel Project and evaluate potential opportunities to pursue active development. San Gabriel will provide an update regarding further progress in its next status report on February 1, 2013.
