

Dear Ms. Jones:

On July 31, 2008, the California Energy Commission ("Commission"), as part of its Data Adequacy Review of Mirant Willow Pass, LLC's ("Mirant Willow Pass") Application for Certification ("AFC") for the Willow Pass Generating Station ("WPGS"), requested the following:

Please provide copies, under confidential cover, of all technical reports whose survey coverage is wholly or partly within .25 mile of the area surveyed for the project or copies of any studies reporting on any archeological excavations or architectural surveys within the literature search area. The technical reports that appeared to be missing are: S-009095, 009214, 009583, 10268, 013256, 013831, 017890, 017993, 018352, 018440, 022464, 22929, 022930, 24322, 024323, 024986, 030387, 030579, 031375, 032182, 034161, 034182.

In response to the Commission's request for missing technical report S-024986 (Basin Research Associates, Inc. Cultural Resources Assessment, Pacific Gas & Electric Company Proposed Tri-Valley 2002 Electric Power Capacity Increase Project), Mirant Willow Pass stated that the requested report was currently unavailable from the Northwest Information center at Sonoma

State, and indicated that Mirant Willow Pass would request a copy from the original researcher and provide it to the Commission. Mirant Willow Pass has received a copy of technical report 5 X-024986 from the original researcher and is enclosing a copy herein.

Mirant Willow Pass requests that the Commission designate and maintain the technical report A-024986 as confidential. This request is made in accordance with the Commission's letter dated August 28, 2008, granting Mirant Willow Pass's request for confidential designation of the Cultural Resources Literature Search Results which Mirant Willow Pass submitted as part of Mirant Willow Pass's AFC.
