Thank you for your July 3, 2008 letter enumerating items not mentioned in the Errata. Please be assured that each of these items has been changed for the Final Decision as indicated in your letter. In an effort to keep the Errata down to a manageable size we included in it only those items from the parties' Comments which were not agreed upon until after the Committee Conference, along with other changes not proposed by the parties, and changes which were viewed as being of enough significance to be included in the Errata.

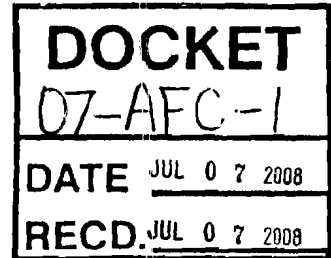
As to BIO-12, all but one of the changes set forth in the Comments on the PMPD were agreed upon at the Committee Conference. The only change that was agreed upon later was the change to paragraph 14 of BIO-12, as set forth in your letter dated June 25, 2008, and thus we included that change in the Errata. Please be assured that BIO-12 in the Final Decision will read as set forth in Staff's Comment, with the exception of the change to paragraph 14 which is set forth in the Errata.
