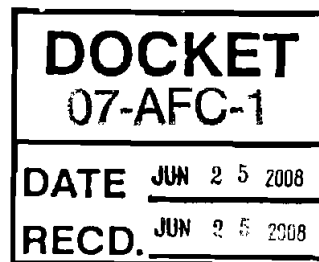



LAND-2, BIO-10 and BIO-12

During the Committee Conference and Evidentiary Hearing held on June 17, 2008, the Committee directed applicant and staff to develop revised language for Conditions LAND-2, BIO-10 and BIO-12 based on discussions held during the Conference and Hearing. The following proposed revisions have been developed jointly by applicant and staff for incorporation into the final decision.

LAND-2: The Condition and Verification should be replaced with the following:

LAND-2: The project owner shall adjust the boundaries of all parcels or portions of parcels that constitute the Victorville 2 project site as necessary to create a single parcel, under single ownership, within the City of Victorville jurisdiction, in accordance with provisions and procedures set forth in the City of Victorville's Municipal Code, Title 17 (Subdivision Ordinance).

Verification: At least 30 days prior to construction of the Victorville 2 project, the project owner shall submit evidence to the CPM indicating site control for all parcels that comprise the Victorville 2 project site. Upon obtaining legal ownership of all parcels that comprise the Victorville 2 project site, the project owner shall commence an action to create a single parcel of all such parcels. Within 10 days of the completion of the creation of a single parcel of all parcels that comprise the Victorville 2 project site, the project owner shall provide evidence of the creation of a single parcel to the CPM.

BIO-10: The Verification should be revised as follows:

Verification: At least 60 days prior to start of any project-related ground disturbance activities, the project owner shall provide the CPM with the final version of the BRMIMP, which includes ~~nesting bird survey results and~~ any necessary impact avoidance measures. All modifications to the approved BRMIMP must be made only after review and approval by the CPM in consultation with CDFG and USFWS.

BIO-12: The third sentence of paragraph 14 should be revised as follows:

All translocated animals found during a dawn to dusk search will be monitored monthly to include for at least 18 months two consecutive spring seasons, after which transmitters will be removed.

Cultural Resources Section

The parties also agreed to provide replacement language for the statement at PMPD page 231, paragraph 1, concerning the historic transmission line. The replacement language, which was developed jointly by applicant and staff, is as follows:

“While the original line will be located within the same right-of-way, aApproximately 10 miles of the original route of the this line would will be used as Segment 3 of the project transmission line.”


