# COMMITTEE SCHEDULING ORDER

On June 25, 2007, CPV Sentinel, LLC, (CPV Sentinel) submitted an Application for Certification (AFC) to the California Energy Commission to construct and operate a simple-cycle (peaking) power plant. The CPV Sentinel Project (Sentinel) is a proposed nominally rated 850 megawatt (MW) electrical generating facility that would encompass 37 acres of land situated within unincorporated Riverside County, California, adjacent to the Palm Springs northern city limits. The proposed project consists of eight natural gas-fired General Electric (GE) LMS100 combustion turbine generators (CTGs) operating in simple-cycle mode.

The Energy Commission assigned a Committee of two Commissioners to conduct proceedings on the AFC. The Committee held a public Informational Hearing in the City of Desert Hot Springs on October 5, 2007 to discuss the review process and to identify issues that could affect the schedule. Pursuant to Title 20 of the California Code of Regulations section 1709.7(c), the attached Committee Schedule is based on Applicant's and Staff's proposed schedules and related discussion at the Informational Hearing.

The schedule contains a list of events that must occur in order to complete the certification process within twelve months. This initial schedule covers the period up to the Prehearing Conference. The balance of the schedule will be determined at the Prehearing Conference.

Several deadlines are contingent upon reviews to be conducted by federal, state, and local agencies. The applicant, CPV Sentinel, must provide sufficient review time for the responsible agencies to meet the deadlines specified in the schedule.

Technical issues regarding air quality and water resources are pending. Resolution of these issues shall be addressed during the data exchange process and public meetings

with the South Coast Air Quality Management District and Mission Springs Water District. Given the complexities involved in resolving the issues, the parties are on notice that we may modify the schedule at any time upon either our own motion or that of a party. [Cal. Code Regs., Title 20, § 1709(c)].

The schedule requires periodic status reports to determine whether case development is progressing satisfactorily and to bring potential schedule delays or other relevant matters to our attention. The burden is on the Applicant to produce the necessary data according to schedule. If there are delays, we may adopt a performance approach resulting in a commensurate slip of the schedule.

In addition to providing printed copies, the parties shall e-mail their status reports to the Hearing Officer and to those with e-mail addresses as indicated on the Proof-of-Service list.
