In reviewing the data request, the response from HECA, and our own staff's maps of the area it is clear that the applicant has attempted to survey the area south of Stockdale (Bellevue Rd) as well and has completed some of that work. However, there are areas to which they have not had access, some of which may be related to agriculture production/irrigation activity, and some areas due to not having access to do the cultural resource surveys from the property owners. Your questions regarding specific areas would best be posed to the HECA team, and I have copied the project manager on this email.
