NOTICE OF APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

CPV SENTINEL INTERCONNECTION 220 KILOVOLT (KV) TRANSMISSION LINE PROJECT

Date: December 16, 2008

Proposed Project: Southern California Edison Company (SCE) has filed an application with the California Public Utilities Commission (CPUC) for a Certificate of Public Convenience and Necessity (CPCN) for the CPV Sentinel Interconnection 220 kV Transmission Line Project (Proposed Project) between the CPV Sentinel Energy Project's generating facility and SCE's existing Devers Substation.

The Proposed Project includes the following elements:

- Construct a new, approximately 0.40 mile-long, 220 kV transmission line that would connect the 850 MW gas fired turbine generators at the Sentinel generating facility with the existing Devers Substation. The proposed 220 kV transmission line would be strung with bundled 1590 kcmil conductor with nonspecular finish. SCE would install 3 tubular steel poles and 2 lattice steel towers for the Proposed Project. These structures would range in height from 80 ft to 165 ft.
- The 0.40 miles of the proposed new line would mostly be located within SCE's existing right-of-way (ROW) immediately south of Devers Substation. The Proposed Project will cross under two existing 220 kV transmission lines, one existing 500 kV transmission line; and crosses over three existing 115 kV transmission lines. The Proposed Project will span into SCE's Devers substation on an existing SCE lattice steel tower. To accommodate the Proposed Project, a single span will be removed from the Devers - Julian Hinds 220 kV transmission line and the remainder of this line will be strung onto the Proposed Projects' second new lattice steel tower.

Construction is scheduled to begin by the fourth quarter of 2009. The Proposed Project is scheduled to be completed and operational by mid-2010.

EMF Compliance: The California Public Utilities Commission (CPUC) requires utilities to employ "no cost" and "low cost" measures to reduce public exposure to electric and magnetic fields (EMF). In accordance with "EMF Design Guidelines" filed with the CPUC in compliance with CPUC Decisions 93-11-013 and 06-01-042, SCE would implement the following measure for the Proposed Project:

- Implementing phasing arrangement(s) to reduce magnetic field levels at edge(s) of ROW.

Environmental Assessment: CPV Sentinel, LLC filed an Application for Certification for the CPV Sentinel Energy Project, including the 0.40 mile long 220 kV transmission line, with the California Energy Commission (CEC). The CEC, in Docket No. 07-AFC-3, has released the Final Staff Assessment on October 10, 2008.

Formal Protests: Formal protests to the application must comply with Article 1 and Rule 2.6 of the CPUC's Rules of Practice and Procedure (posted on the CPUC's website at www.cpuc.ca.gov). Formal protests must state the facts constituting the grounds for the protest, the effect of the application on the protestant, and the reasons the protestant believes the application, or a part of it, is not justified. If the protest requests a hearing, it must state the facts you would present at a formal evidentiary hearing to support your protest. Any affected party may, within 30 days of the date on this notice, i.e. no later than **January 16, 2009**, protest and request that the CPUC hold hearings on the application.

Letters: If you wish to make your views known without participating formally, you may write to the CPUC at 505 Van Ness Avenue, San Francisco, CA 94102. Your communication will be directed to the Commissioners and the Administrative Law Judge for review, and will be placed in the proceeding's formal Correspondence File.
