

Good morning - As you both know, staff did not file a proposed schedule for the remainder of the Sentinel AFC proceeding last Friday. We apologize for missing the deadline. Having reviewed the applicant's proposed schedule, staff would like to offer a similar schedule, but one that allows 60 day between the PSA and the FSA. The water section of the PSA will not be complete when the PSA is filed this Thursday. In addition, there is no FDOC for the project, and the applicant still needs to provide additional public information about the proposal to purchase water from out of basin for recharge in the basin in which the project is located. An FSA publication date of September 30 should allow for resolution of all these issues.

In addition, staff respectfully requests that the Committee leave open the schedule for the applicant's filing of testimony until it is known if there will be any uncontested issues. If there are not, very little time is needed between that filing and the hearings. However, if there are contested issues, staff will need at least two weeks after the applicant files testimony in order to adequately prepare for the hearings.


