Pursuant to the Revised Committee Scheduling Order for the Hydrogen Energy California Project (Project), issued on January 30, 2013 we hereby file this Status Report No. 5 on behalf of Hydrogen Energy California LLC (HECA or Applicant). This Status Report provides an overview of key activities by HECA since January 9, 2013, when HECA submitted Status Report No. 4.

As shown below, the Applicant is actively engaged in public outreach and agency coordination to facilitate review of the Project. The Applicant is diligently working to resolve all outstanding Data and Workshop Requests by Staff for the California Energy Commission (CEC) and other parties. The Applicant believes that Staff currently has adequate information to prepare the Preliminary Staff Assessment (PSA) by March 15, 2013 as scheduled.

In February, Applicant participated in the B-Safe community meeting and the B-Safe action committee meeting. Applicant donated meal tickets for the upcoming Buttonwillow Pioneer Senior Citizen and Resource Center Barbecue to be held on March 1<sup>st</sup>.

Applicant created and placed an informational ad series in the Kern Business Journal to help educate the public and business community on the benefits of the project to the local region.
